May 4, 1886 The Haymarket Riot

- 1. Workers in Chicago and New York City are demanding an 8 hour work day instead of 10, and, a stoppage to Police violence against them!
- 2. Management has refused the demands!
- 3. Chicago 40,000 workers go on strike!
- 4. Monday May 3, 1886 Chicago:
 - A) 10,000 workers attack the McCormick Reaper works on Western Avenue:

 Patrol Wagon – 12 Policmen – Arrives.
 Draw pistols – Order crowd to disperse.
 Draw pistols – Order crowd to disperse.
 Hit by a volley of rocks.
 Fire over the head of the crowd.
 Fire over the head of the crowd.
 Police are cursed and jeered at!
 VI. Fire into the workers hitting several!
 VII. Workers fire back – Hit nobody.
 VIII. More Police arrive – Crowd dispersed.

- 3. 2 Ranchers, Kels Nickell and Jim Miller, hate each other!!!
- 4. Summer of 1901 Nickell brings in Sheep:

- July 18, 1901 Willie Nickell 14 year old son
 Is shot to death ¾ of a mile from the Nickell Ranch:
