The fingerprints were taken of the man shot, but they did not match those of Dillinger, therefore they were not sent in, because if they were the F.B.I. would then have to admit the wrong man was killed.

Dillinger's sister, Audrey, said she could positively identify her brother by a scar on his leg. After viewing the body she said 'There's no question in my mind. Bury him.' But, what she was really looking for was a birth mark, which was not there. But naturally by saying this she protected both Dillinger and the F.B.I.

The man shot had black hair and brown eyes.

 Bryan have you ever pondered what would have happened to the earth if it had stood still?
- **B** No. The God I believe in could have taken care of that Mr. Darrow.
- D Don't you know it would have been converted into a mass of molten matter?
- **B** I don't think I've ever had the question asked.
- **D** Or ever thought of it?
- **B** I don't think about things I don't think about/
- **D** Do you ever think about things you do think about?
- **B** Well, sometimes!

**Audience laughs hysterically - Bryan is mad, confused, and being made a fool of!

- **D** When did the flood occur?
- **B** I wouldn't attempt to fix the date.
- D But, doesn't every printed Bible say that the flood had happened about 4004 B.C.?
- **B** Yes, that's the estimate given.
- **D** How was the estimate arrived at?
- **B** I never made a calculation.
- **D** A calculation from what?
- **B** I couldn't say.

- **D** From the generations of man?
- **B** I wouldn't want to say that.
- D Bishop Ussher, calculating from the ages of the various prophets in scriptural episodes has computed the date of creation as October 23, 4004
 B.C. at 9:00 A.M. Do you believe that all of the species on the earth had come into being in the 4,200 years, by the Bishop's dating, since the flood occurred?
- **B** Yes, I believe it!
- **D** Do you believe that all living things that were not contained in the ark were destroyed?
- **B** I accept that, as the Bible gives it, and I have never found any reason for denying, disputing, or rejecting it.
- D So, that 4,200 years ago there was not a living thing on the earth excepting the people on the ark and the fishes. Don't you know that there are any number of civilizations traced back to more than 5,000 years?
- B I know we have people who trace things back according to the number of ciphers they have. But I'm not satisfied they're accurate. I have never felt a great deal of interest in the effort that has been made to dispute the Bible by the speculations of men, or the investigations of men.
- **D** Do you say you don't believe that there were any civilizations on this earth that reach back 5,000 years?
- B I'm satisfied by no evidence I've found that would justify me in accepting the opinions of these men against what I believe to be the inspired word of God.
- **D** Do you know of a single scientific man on the face

of this earth that believes any such thing as you stated?

- **B** No sir. I've been so well satisfied with the Christian religion that I've spent no time trying to find arguments against it.
- **D** Do you think the earth was made in 6 days?
- **B** Not 6 days of 24 hours!

**Shocked reaction from the audience - Has just denied the Bible literally!!!!

D - (Reads from Genesis) The morning and evening

were the 1st day. Do you believe that the sun was created on the 4th day?

- **B** Yes.
- **D** How could there have been an evening and morning of the 1st day without any sun?
