- February 1960 Las Vegas, Nevada Frank Sinatra introduces John F. Kennedy to actress, Judith Campbell.
- 2. March 7, 1960 Affair between Campbell and Kennedy starts.
- 3. Fact known today.....1960 to late spring of 1963....The C.I.A. and the Mafia will plot together to assassinate Fidel Castro of Cuba!!
 - A) 1st contacts between the 2 is in 1959.
 - B) Why?
 - I. For the C.I.A.....Get Communism out of Cuba!
 - II. For the Mafia.....Get back into Cuba for gambling, prostitution, and drugs!
 - C) From 1960 to 1963.....8 different plots to kill Castro.
 - D) The "Hit Castro" braintrust:
