  - (9) 9:46 Morning 2 National Guard helicopters start dropping tear gas.
  - (10) Snipers open fire Assault with rifles and shotguns.
  - (11) Lasts for 4 minutes.
  - (12) Won't be until 2:00 in the afternoon that the last of the resisters are brought out of the D Block yard.
  - (13) 32 inmates have been killed.
  - (14) 200 inmates injured 13 require surgery.
  - (15) 30 hostages have survived.
  - (16) Prison officials report that 9 have had their throats slashed.
  - (17) Autopsies reveal.....all 9 killed by friendly gunfire.....not 1 has had their throat slashed!!!

- 3. John Ehrlichman is Nixon's Head of Domestic Affairs.
- 4. May 12, 1969 With the knowledge of President Nixon Illegal wiretaps are placed on 4 government officials, 3 National Security Council members, and a member of the Department of Defense:
  - (1) Following week.....2 more Security Council Members.
  - (2) Following week....2 Newsmen.
  - (3) Over the next 2 months.....17 more people!
- 5. June 1969 Tony Ulasewicz is hired by John Ehrlichman and Herb Kalmbach:
  - (1) He is a former detective.
  - (2) Job is to carry out political espionage for the White House.
  - (3) To work directly under John Caulfield.
  - (4) Salary is to be \$22 thousand per year Later, 24! Plus, \$1 thousand per month for expenses.
  - (5) Money is to be paid out of Herb Kalmbach's office!
  - (6) To get sex, drinking, or family problems on political opponents of the President or contributors to his rivals.
  - (7) 1<sup>st</sup> job he is given is to find out all concerning Ted Kennedy, Mary Jo Kopechne, and her drowning at Chappaquiddick in July of 1969.
- 6. 47 year old, Herb Kalmbach, is Nixon's personal Attorney and his Presidential Campaign Fund Raiser:

  - (2) Barker starts assembling a team:
    - A) 49 year old, Frank Sturgis:
      - I. Ex-Marine Has fought in Castro's army.
      - II. Has worked for the CIA.
    - **B)** Eugenio Martinez:
      - I. Cuban Salesman in Barker's agency.
      - II. Has smuggled refugees out of Cuba for the CIA.
    - C) 45 year old, Virgilio Gonzalez:
      - I. Cuban Locksmith in Miami.
- 32. Winter of 1971 Nixon starts tape recording all of his conversations for posterity:
  - (1) Same time John Dean and John Caulfield start an illegal tax

crackdown operation against Nixon's political "enemies":

- 35. January 1972 John Caulfield is assigned to CREEP as Jeb Magruder's aide.
- 36. January 27, 1972 4:00 Afternoon Office of the Attorney General of the United States of America, John Mitchell:
  - (1) Meeting: Mitchell John Dean Jeb Magruder and G. Gordon Liddy:
    - A) Liddy shows charts of his proposed illegal million dollar political espionage plan:
      - I. Kidnapping any "radical" demonstrators at the Republican Convention - Take them deep into Mexico and dump them off!
      - II. Wiretapping Democrats at their headquarters in Washington, D.C.!
      - III. Wiretapping Democrats at their convention in Miami.
      - IV. Lure prominent Democrats aboard a "loaded" yacht Film them with prostitutes Blackmail and ruin them!

  - (2) Liddy's 3<sup>rd</sup> set of plans Breakdown of costs:

  - (4) Same stationary Phony accusation that Senator Hubert Humphery is caught in a car with a hooker in 1967.
  - (5) Same stationary Phony accusation that Senator Henry "Scoop" Jackson is twice arrested in the 1950's for homosexual activities.
- 42. March 30, 1972 Key Biscayne, Florida Villa rented for John Mitchell be millionaire, Bebe Rebozo Meeting between Mitchell, Magruder, and 42 year old, Fred LaRue:
  - (1) LaRue:

  - (3) Magruder authorizes him to give the money to Liddy.

  - (5) Stans asks Mitchell.
  - (6) Mitchell says to give him the money.
  - (7) Stans:
    - A) Head of CREEP's Campaign Finance Committee.
- 46. April 9, 1972 Golf course Ken Dahlberg, Nixon's mid-West fund raising chief Is handed a \$25 thousand by Dwayne Andreas, a Minneapolis soybean millionaire:
  - (1) Dahlberg converts it to a bank check.
  - (2) Flies to Washington, D.C.!
  - (3) Gives it to Stans.
  - (4) Stans gives it to Sloan.
  - (5) Sloan gives it, and 4 checks drawn on a Mexican bank, totaling \$89 thousand to Liddy.
- 47. April 12, 1972 Liddy gives James McCord \$65 thousand to buy electronic equipment.
- 48. April 1972 Liddy tells Hunt that the Democratic National Committee Headquarters in the Watergate Hotel in Washington, D.C. will be the target for electronic surveillance.
- 49. Strachan picks up \$350 thousand for Haldeman and gives it to <u>Alexander Butterfield</u> to keep for Haldeman:

- (1) Butterfield is a Deputy Assistant to Nixon.
- 50. April 19, 1972 Gulf Resources and Chemical Corporation telephones and transfers \$100 thousand to the International Bank in Mexico City.
- 51. April 20, 1972 Bernard Barker deposits the 4 checks given to him by Liddy totaling \$89 thousand:
  - (1) Have been drawn on the International Bank in Mexico City.
  - (2) This is called "washing campaign funds."
- 52. April 24, 1972 Barker withdraws \$25 thousand.
- 53. May 1, 1972 Barker withdraws \$33 thousand.
- 54. May 8, 1972 Barker withdraws \$56 thousand:
  - (1) Total.....\$114 thousand!!!
- 55. May 16, 1972 The law offices of Democratic Vice Presidential candidate to be, R. Sargent Shriver and Democratic Party Credentials Committee Chief, Patricia Harris are broken into!!
- 56. May 26, 1972 McCord, Sturgis, Barker, Gonzalez, and Martinez check into the Watergate Hotel under false names:
  - (1) While they are there 2 attempts are made on May 27<sup>th</sup> to break into the DNCH.
  - (2) Men check out.
- 57. June 10, 1972 Sturgis and Barker visit Michael Richardson's photo shop:
  - (1) Bring him frames of film to be processed.
  - (2) Show surgically gloved hands holding DNCH documents.
- 58. June 16, 1972 The same 5 men again register at the Watergate Hotel:
  - (1) Liddy and Hunt register at the Howard Johnson's across the street from the Watergate.

  - A) 5 burglars break into the DNCH on the 6<sup>th</sup> floor of the Watergate Office Building next door to The Watergate Hotel in Washington, D.C.:
    - I. 2:00 Morning.
    - II. 24 year old, Black security guard, Frank Wills is on his rounds:
      - a. Notices tape on door locks.
      - **b.** Calls Police.
    - III. 3 plainclothes Policemen arrive.
    - IV. Start a room by room search on the 6<sup>th</sup> floor.
    - V. From across the street Liddy and Hunt try to warn the men by walkie-talkie.
    - VI. 2:30 Morning Larry O'Brien's office At gunpoint The 5 men are arrested!
    - VII. Liddy and Hunt flee from Howard Johnson's.
  - B) The 5 men are all dressed in business suits:
    - I. All are wearing surgical gloves.

- 60. Same day.....9:00 Morning:
  - A) Bob Woodward Reporter for "The Washington Post" Is at home:
    - I. Call from the paper.
    - II. Told of the break-in.
    - III. Told to cover the arraignment!
  - **B) Goes to courthouse:** 
    - I. Attorney, Douglas Caddy, is there:
      - a. Woodward asks him if he is representing the men.



- a. Today.....the address is 1820 North Nash Street.
- B) Named "Deep Throat" by Washington Post Managing Editor, Howard Simons:
  - I. Deep background!

- 75. Same day Democratic National Chairman, Larry O'Brien files a 1 million dollar lawsuit against the 5 men for invasion of privacy.
- 76. Same day Strachan meets with Haldeman:
  - (1) Shows Haldeman a copy of a political intelligence memorandum.
  - (2) Haldeman reads it Orders Strachan to shred it!
  - (3) He does so, along with other related documents.
- 77. Same day Mitchell issues a press release denying any legal, moral, or ethical involvement of CREEP in the break-in.....LIE!!!
- 78. Same day Liddy meets with Mardian and LaRue in LaRue's apartment:
  - (1) Liddy tells them that "commitments have been made to myself and others."
- 79. Wednesday June 21, 1972:
  - (1) 9:35 Morning Ehrlichman meets with <u>L. Patrick Gray III:</u> <u>A) Acting Director of the FBI.</u>
  - (2) Tells Gray that John Dean will be handling the Watergate Investigation for the White House.
  - (3) Tells Gray he should work with Dean.
  - (4) 11:30 Morning Dean meets Gray in Gray's office.
  - (5) Discuss the investigation.
  - (6) Dean tells him he will sit in on FBI interviews of White House staff members for the President.
- 80. Same day LaRue's apartment Liddy, Mardian, and LaRue meet again:
  - (1) Liddy tells them:
    - A) He and Hunt planned the DNCH break-in.
    - B) He and Hunt planned the break-in of McGovern's office.
    - C) He and Hunt planned the break-in of Ellsberg's psychiatrist's office.
    - D) That Hunt has shredded all the \$100 bills in his possesion.
    - E) That Hunt has destroyed other evidence related to the Watergate break-in.
- 81. Same day Mardian and LaRue meet with Mitchell:

- (1) Tell Mitchell of Liddy's and Hunt's actions.
- 82. Thursday June 22, 1972 Ehrlichman meets with Dean:
  - (1) Discuss the contents of Hunt's safe.
- 83. Same day FBI interviews Colson with Dean present:
  - (1) Ask about Hunt's office.
  - (2) Dean says he will have to check and see if Hunt has an office!?!
- 84. Same day Nixon makes a public statement: "Such an act has no place whatever in our electoral process, or in our government process. The White House has had no involvement whatever in this particular incident.".....LIE!!!
- 85. Friday June 23, 1972 Nixon orders the CIA to halt the FBI investigation because it could be politically embarrassing to his reelection.....THIS IS DIRECT OBSTRUCTION OF JUSTICE!!!!!
  - (1) Has message delivered to Gray urging the FBI to stop the investigation.
- 86. At this point:
  - (1) Nixon knows Mitchell is involved in the break-in and coverup.
  - (2) Nixon has ordered the investigation stopped on the advice of Mitchell to Dean to Haldeman to Nixon!
- 87. Saturday June 24, 1972 CREEP headquarters Mitchell, Mardian, and Dean meet:
  - (1) M & M ask Dean to ask the CIA to provide secret funds Liddy, Hunt, and the other 5 men.
  - (2) Mardian is to direct CREEP's internal investigation of Watergate.
- 88. LaRue is destroying any CREEP records that will link CREEP to the bugging, break-in, or coverup.
- 89. Monday June 26, 1972 White House Ehrlichman meets with Dean:

- (1) Ehrlichman meets with Dean at the White House:
  - A) Ehrlichman approves the suggestion that Dean ask General Vernon Walters of the CIA to secretly pay for the salaries and bail money for the Watergate 7:
    - I. Later in the day Dean asks him Answer.....NO!!!!
- 90. Tuesday June 27, 1972 Dean and his assistant, Fred Fielding deliver only portions of the contents of Hunt's safe to the FBI.
- 91. Wednesday June 28, 1972 FBI agents meet with Liddy Question him He refuses to answer:
  - (1) Shortly With Mitchell's approval, Maurice Stans fires Liddy from CREEP.
  - (2) Same day Dean, L. Patrick Gray, and Ehrlichman meet in Ehrlichman's office:
    - A) Dean gives Gray the remaining 2 file folders from Hunt's safe:
      - I. Tells Gray.... "These papers should never see the light of day."
  - (3) Same afternoon Dean, Mitchell, Magruder, and LaRue plan the cover-up:
    - A) Decide bribery and perjury will have to be used.
    - B) Decided that Mitchell will resign the leadership of CREEP but Magruder will stay.
    - C) Late afternoon Haldeman and Ehrlichman give Dean approval for the plan:
      - I. Dean calls Herb Kalmbach in Los Angeles and tells him to fly to Washington.
- 92. Thursday June 29, 1972 Dean meets with Kalmbach:
  - (1) Tells him to raise enough cash to pay the legal and support costs of the Watergate 7:
    - A) Says it will take between 50 and 100 thousand dollars:
      - I. Kalmbach passes the message to Stans.
      - II. Stans brings him \$75 thousand in \$100 dollar bills.
- 93. Friday June 30, 1972 Tony Ulasewich picks up the money to be delivered to the Watergate 7 and their lawyers.
- 94. Saturday July 1, 1972 Mitchell resigns from CREEP.

- 95. Monday July 3, 1972 Gray destroys the 2 file folders from Hunt's safe that Dean has given him.
- 96. Thursday July 6, 1972 Gray talks to Nixon:
  - (1) Warns Nixon that people close to him are meddling in the investigation:
    - A) Nixon simply dismisses it!!!!
- 97. Friday July 7, 1972 Hunt surrenders to authorities:
  - (1) same day Ulasewicz delivers \$25 thousand in cash to Hunt's lawyer.
- 98. July 17, 1972 Washington National Airport Ulasewicz delivers another \$40 thousand to Hunt's wife, Dorothy.
- 99. July 19, 1972 Mitchell, Dean, and Ken Parkinson (Lawyer for CREEP) Meet at CREEP headquarters:
  - (1) Mitchell asks Dean to get FBI reports on the Watergate investigation for Parkinson and others.
  - (2) Same day Bart Porter (35 year old Aide to CREEP) lies to the FBI:
    - A) Tells them the money he gave to Liddy was for lawful political activities.
- 100. July 21, 1972 Mardian meets Dean at the White House They examine FBI reports on the Watergate Investigation:
  - (1) This is totally illegal!!!!!!!
- 101. July 26, 1972 Ehrlichman meets with Kalmbach at the White House:
  - (1) Kalmbach asks him if Dean has the authority to order him to raise secret funds for the Watergate 7 and their lawyers:
    - A) Ehrlichman tells him.....YES, and.....that he should continue to raise funds and make payments.....<u>AND</u>.....keep everything secret!!
- 102. July 31, 1972 Ehrlichman, Dean, and Attorney General Kleindienst meet:
  - (1) Discuss whether Magruder is involved in the break-in and/or

- cover-up.
- (2) Later Same day Ehrlichman discusses the meeting with Nixon.
- 103. August 26, 1972 The General Accounting Office charges the financial committee of CREEP with violation of U.S. election laws.
- 104. August 29, 1972 Nixon addresses the nation:
  - (1) Denies that anyone on his staff or employed by his administration is involved.....LIE!!
  - (2) Promises that there will be no attempt to cover up the facts.....LIE!!
  - (3) Announces that John Dean has probed the matter clearing everyone then employed in the White House....LIE!!
    - A) Dean has never been asked to/or conducted such an investigation!
- 105. September 11, 1972 Larry O'Brien amends his original lawsuit to \$3 million and names Stans, Liddy, Hunt, and Hugh Sloan Jr.:
  - (1) Charges are:
    - A) Conspiracy to obtain Democratic party information by means including theft, photographing documents, and installing and monitoring wiretapping and eavesdropping devices.
- 106. September 12, 1972 Noon Mitchell, Dean, and Magruder meet:
  - (1) Magruder tells them the false story he will tell the Watergate Gramd Jury in regards to meetings between himself, Mitchell, Dean, and Liddy.
- 107. September 13, 1972 CREEP sues Larry O'Brien for \$2 ½ million.
- 108. September 14, 1972 Mitchell testifies before the Watergate Grand Jury:
  - (1) Says he had no prior knowledge of illegal CREEP political intelligence operations <u>or</u> of Liddy's political intelligence gathering activities.....OUTRIGHT LIE!!!!!!
- 109. September 15, 1972 Nixon and Haldeman call Dean in:

- (1) Congratulate him on his handling of the Watergate matter:
  - A) Nixon tells him: "Great job John. Bob told me what a great job you've been doing."
- (2) Same day A Federal Grand Jury indicts the Watergate 7:
  - A) Charges are:
    - I. Conspiracy to use illegal means to monitor phone calls and conversations of Democratic party officials.
    - II. Conspiracy to steal certain documents.
    - III. Conspiracy to photograph certain documents.
    - IV. Illegally entering Democratic committee offices with intent to steal property and to intercept conversations.
- (3) Hunt, Barker, Sturgis, Gonzalez, and Martinez plead "guilty."
- 110. Week of September 18, 1972 It is confirmed that Liddy and Hunt were at the Howard Johnson's Motor Lodge across the street from the Watergate monitoring the break-in:
  - (1) From San Clemente, California Nixon issues a statement that none of his current staff is involved in the break-in.....LIE!!!
- 111. Week of September 25, 1972 John Mitchell makes a public statement: "The people involved were not operating either on our behalf, or with our consent."
  - (1) LIE!!!!!
- 112. October 5, 1972 Nixon says he is pleased with the FBI investigation of the Watergate matter....LIE!!
  - (1) Denies knowing anything about the break-in....LIE!!
- 113. October 9, 1972 Learned that John Mitchell held personal control of a \$350 to \$750 thousand fund to be used for political intelligence gathering against the Democrats.....while he was still Attorney General!
- 114. October 22, 1972 "Deep Throat" tells Woodward that Haldeman controls campaign funds used for sabotage activities.
- 115. November 10, 1972 Dean meets with Segretti in Palm Springs, California:
  - (1) Segretti tells him all about his "dirty tricks" political espionage

#### activities while employed by Chapin.

- 116. November 13, 1972 Hunt and Colson talk by phone:
  - (1) Hunt tells him additional payments to the defendents will be needed.
- 117. Early December 1972 Haldeman and Dean talk by phone:
  - (1) Haldeman approves the use of part of a \$350 thousand fund under his control for the defendents.
  - (2) Gordon Strachan meets with Fred LaRue in LaRue's apartment:
    - A) Strachan gives him \$50 thousand in cash.
    - B) LaRue arranges for \$40 thousand in cash to be delivered to Hunt's attorney.
- 118. December 8, 1972 United Airlines flight #533 A Boeing 737 Takes off from Washington National Airport headed for Midway Airport in Chicago:
  - (1) Crashes Kills 43 passengers and 2 people on the ground.
  - (2) 15 passengers survive.
  - (3) One of the dead is Hunt's wife, Dorothy:
    - A) Is carrying \$10,585.00 in \$100 dollar bills.
    - B) Legal investigator, Sherman Skolnick, claims it is sabotage:
      - I. Pilot, Wendell Whitehouse, dies of cyanide poisoning before the crash.
- 119. January 3, 1973 Colson, Dean, and Ehrlichman meet at the White House:
  - (1) Discuss the need to assure Hunt how long he will have to stay in jail if he is convicted:
    - A) In other words.....Executive Clemency!!
    - B) Shortly after the meeting, Colson discusses the issue with Nixon.
- 120. January 4, 1973 Ehrlichman assures Colson that he can tell Hunt he will receive executive clemency!!
- 121. Early January 1973 Haldeman talks to Dean and authorizes the use of the remaining \$350 thousand "slush fund" for the defendents.

- (1) In LaRue's apartment LaRue gives Strachan \$300 thousand in cash.
- 122. January 8, 1973 Trials of the Watergate 7 start:
  - (1) They plead guilty.
  - (2) Watergate Judge is John Sirica.
  - (3) Prosecutor is Asst. Attorney General, Earl Silbert:
    - A) He claims Magruder and Porter requested political intelligence from Liddy.
  - (4) Same day <u>Democratic North Carolina Senator</u>, <u>Sam Ervin</u> agrees to head a Congressional investigation of Watergate.
- 123. January 11, 1973 Hunt pleads guilty in court.
- 124. January 12, 1973 Caulfield offers McCord Executive Clemency.
- 125. January 14, 1973 Caulfield makes a 2<sup>nd</sup> offer to McCord.
- 126. January 15, 1973 Barker, Sturgis, Gonzalez, and Martinez plead guilty in court:
  - (1) It is learned that the defense money is coming from Republican party funds.
- 127. January 25, 1973 Caulfield makes a 3<sup>rd</sup> Executive Clemency offer to McCord.
- 128. January 30, 1973 Jury is out only 90 minutes Liddy and McCord are found "guilty" of all charges.
- 129. February 7, 1973 U.S. Senate votes 77-0 to establish the Senate Select Committee on Presidential Campaign Activities.
- 130. February 27, 1973 Dean meets and talks with Nixon:
  - (1) Nixon tells him that Haldeman and Ehrlichman are major participants in the Watergate case.
  - (2) Tells Dean to report directly to him from now on.
- 131. February 28, 1973 Dean meets with Nixon again:
  - (1) Dean tells Nixon that he (Nixon) is involved in the cover-up and

that is obstruction of justice:

- A) Nixon tells him: "Not to worry John, I have no legal problems."
- 132. March 2, 1973 Nixon issues a statement of Executive Privilege to John Dean:
  - (1) Means he, Nixon, will not allow his counsel to testify before the Watergate Committee.
- 133. March 13, 1973 Dean meets with Nixon and Haldeman:
  - (1) Dean tells them that the Watergate 7, most notably Hunt, want more money to keep quiet and that it might cost a million dollars or more:
    - A) Nixon tells him: "That's no problem. Hunt has been promised executive clemency."
- 134. March 17, 1973 Hunt sends word to Dean that he will talk unless given \$130 thousand in cash before his sentencing on the 23<sup>rd</sup>:
  - (1) There is no more money!!!!!!!!
- 135. March 19, 1973 McCord writes a letter to Judge Sirica claiming that during the trial political pressure was put on the defendents to:
  - (1) Plead guilty.
  - (2) To keep quiet.
  - (3) AND.....perjury occurred.....AND.....others are involved!!!!!
- 136. March 21, 1973 Dean meets with Nixon:
  - (1) Tells Nixon: "There is a cancer growing on the Presidency, and if that cancer is not removed you will be killed by it Mr. President."
  - (2) Tells Nixon that Mitchell has received Watergate wiretap information.
  - (3) Tells Nixon that Kalmbach is raising "hush money."
  - (4) Tells Nixon: "I coached Magruder in how to commit perjury."
    A) Nixon doesn't even act concerned!!!!!
  - (5) Later that day 2<sup>nd</sup> meeting Dean, Nixon, and Haldeman:
    - A) Dean tells them there's a danger facing the Presidency.
    - B) Dean tells them that he (Dean), Haldeman, and Ehrlichman are all indictable for obstruction of justice.

- C) Dean tells them the only solution is for Mitchell to take the rap:
  - I. Nixon orders Dean to buy him some time.
- (6) That night:
  - A) Calls between Dean, Mitchell, Haldeman, and LaRue:
    - I. \$75 thousand is raised.

    - A) Gonzalez 1 to 4 years.
    - B) Martinez 1 to 4 years.
    - C) Sturgis 1 to 4 years.
    - D) McCord 1 to 5 years.
    - E) Barker 2 ½ to 6 years.
    - F) Hunt 2 ½ to 8 years and a \$10 thousand fine.
    - G) Liddy Additional charge of contempt of Congress 6 & 2/3 to 20 years and a \$40 thousand fine.
  - (2) All sentences are deferred until later except Liddy's He is sentenced right then.
  - (3) Same day Gray testifies before the Watergate Committee that "Dean probably lied."

- 144. Last week of March 1973 Gray is suspected of short-circuiting the Watergate investigation out of loyalty to the President:
  - (1) Gray testifies he gave Dean secret FBI reports on the case without asking permission.
  - (2) Mitchell is confronted with McCord's testimony implicating him:
    - A) Mitchell: "I don't know what McCord is talking about."
- 145. April 2<sup>nd</sup> thru the 15<sup>th</sup> of 1973 Dean's lawyers start negotiating with the prosecutors office:
  - (1) Dean tells them all he safely can about the break-in and coverup.
- 146. April 5, 1973 McCord testifies before the Ervin Committee:
  - (1) Implicates Mitchell.
  - (2) Implicates Haldeman.
  - (3) Implicates Dean.

- (4) Implicates Colson.
- (5) Implicates Magruder.
- (6) Says his information comes from Liddy and Hunt.
- (7) Says the defendents have been receiving regular payoffs of \$1 thousand per month to keep quiet.
- (8) Says the money has been delivered by Mrs. Hunt.
- (9) Says the money comes from CREEP!
- 147. April 6, 1973 Dean gives information to the Watergate Prosecution Office in the Justice Department backing up McCord's testimony.
- 148. April 10, 1973 Attorney General Kleindienst claims Congress has no power to compel White House employees to testify except thru a Supreme Court judgement or through impeachment.
- 149. April 11, 1973 Magruder's chief assistant, Robert Reisner appears before the Grand Jury and says Magruder knew all about the break-in and cover-up.
- 150. April 12, 13, & 14, 1973 Magruder's lawyers persuade him to tell all in return for a 1 count felony charge:
  - (1) Does so!!
  - (2) Tells ALL!!
- 151. April 14, 1973 Nixon, Haldeman, and Ehrlichman meet:
  - (1) Decide Mitchell and Dean must be sacrificed and quick!
  - (2) Mitchell arrives Talks to Ehrlichman Refuses to take the blame!
  - (3) That evening:
    - A) White House Correspondents Association gives out their \$1 thousand award:
      - I. Woodward and Bernstein for uncovering Watergate!
- 152. April 15, 1973:
  - (1) Morning Dean sends a note to Nixon telling him he is going to talk to the Federal prosecutors:
    - A) Nixon asks for a meeting:
      - I. Meet.
      - II. Nixon tries to ask him leading questions.

- III. Says he was only joking about the 1 million dollars in "hush money."
- IV. Says he was foolish to have discussed Hunt's clemency with Colson.
- V. As Dean leaves he tells Nixon he hopes he will not be impeached!
- (2) Justice prosecutors, Earl Silbert Seymour Glanzer and Donald Campbell meet with Attorney general Kleindienst and Asst. Attorney general Henry Petersen:
  - A) After the meeting Kleindienst and Petersen ask to see Nixon immediately:
    - I. Afternoon Meet Kleindienst tells Nixon that Mitchell, Haldeman, and Ehrlichman are all involved and will be indicted.
    - II. Suggests to Nixon that he appoint a special prosecutor.
- 153. April 16, 1973 Nixon demands a resignation from Dean:
  - (1) Dean refuses.
  - (2) Says he will only resign if Haldeman and Ehrlichman do the same.
- 154. April 17, 1973 Nixon issues a statement waiving executive privilege:
  - (1) "No one in my administration will be given immunity from prosecution. I condemn any attempt to cover up this case no matter who is involved.".....LIE!!!!!
    - A) Means that White House aides can now testify before the Ervin Committee in public:
      - I. <u>But</u> Nixon is still protecting Haldeman and Ehrlichman and in so doing is breaking the law!
- 155. April 19, 1973 John Dean issues a public statement saying he will not be the scapegoat of Watergate.
- 156. April 25, 1973 Nixon, Haldeman, and Ehrlichman meet:
  - (1) Ehrlichman says Dean may talk and if he does.....the President may be impeached!

- 157. April 27, 1973 Gray resigns as Acting Director of the FBI:
  - (1) Same day Nixon decides that Haldeman and Ehrlichman have to go!
- 158. April 29, 1973 Camp David:
  - (1) Nixon fires Haldeman!
  - (2) Nixon fires Ehrlichman!
  - (3) Nixon fires Kleindienst!
  - (4) Replaces Haldeman with General Alexander Haig (On May 4th).
  - (5) Replaces Kleindienst with Elliot Richardson.
- 159. April 30, 1973 Rather than be fired.....Kleindienst resigns:
  - (1) Same day Nixon fires Dean as White House Counsel.
- 160. May 2, 1973 Before the Watergate Grand Jury Hunt admits his part in the break-in of Ellsberg's psychiatrist's office.
- 161. May 7, 1973 Orlando, Florida Donald Segretti is indicted by a Federal Grand Jury for conspiracy to use the U.S. mail for illegal purposes.
- 162. Early May 1973 William Ruckelshaus becomes Acting Director of the FBI:
  - (1) Disclosed that ITT and the Teamsters Union have given secret political contributions to the Republican party.
- 163. May 10, 1973 Nixon announces he has a defense team of lawyers:
  - (1) Dean Burch William Timmons Leonard Garment and Fred Buzhardt Jr.:
    - A) Buzhardt will be his special counsel on Watergate.
  - (2) Same day Mitchell and Stans are charged with conspiring to arrange an unreported \$200 thousand contribution to the Nixon campaign from New Jersey financier, Robert Vesco.
  - (3) At this time:
    - A) Maurice Stans' safe contains cash between \$800 thousand and 1.3 million dollars:
      - I. \$200 thousand of it is from Vesco.
      - II. \$89 thousand is from Texas industrialist, Robert Allen. III. \$25 thousand is from Dwayne Andreas.

- B) Haldeman has \$350 thousand of unreported cash.
- C) Kalmbach has \$500 thousand of unreported cash.
- 164. May 11, 1973 Ellsberg and Russo are acquitted when Judge William Byrne Jr. declares a mistrial and grants a defense motion for dismissal:
  - (1) Under investigation are: Porter Segretti Krogh Sloan Ehrlichman Mardian LaRue Strachan Haldeman Dean Chapin Kalmbach Colson Parkinson Stans Mitchell and Magruder.
- 165. May 17, 1973 The Ervin Committee opens it's hearings to the public.
- 166. May 18, 1973 Attorney General, Richardson appoints <u>Archibald</u> <u>Cox as Special Watergate Prosecutor</u>.
- 167. Week of May 21, 1973 McCord testifies before the Watergate Committee:
  - (1) Was told to be quiet.
  - (2) Was told he would be paid if he kept quiet.
  - (3) Was told the President would grant him executive clemency if he kept quiet:
    - A) All of this was told to him by Caulfield.
- 168. May 22, 1973 Nixon makes a 4,000 word public statement:
  - (1) Had no prior knowledge of the Ellsberg break-in....LIE!
  - (2) Never used the CIA for domestic political purposes....LIE!
  - \*\*\*\*\*IN FACT: There has been a Watergate cover-up, portions of which he has authorized in the name of National security!!!!!
- 169. May 25, 1973 Cox is sworn in as Special Watergate Prosecutor:
  - (1) Nixon does not like him!
- 170. June 6, 1973 Former Secretary of Defense, Melvin Laird is named to replace Ehrlichman:
  - (1) Charles Alan Wright is appointed special legal consultant to Nixon.

- 171. June 25, 1973 Dean starts his testimony before the Ervin Committee:
  - (1) Nixon was personally aware of the cover-up!
  - (2) Nixon and his personnel lied about it!
  - (3) Nixon ordered the report on past abuses by past Presidents to take the heat off himself and justify his misuse of the FBI in the Watergate Scandal!
  - (4) Nixon stated in one conversation that a million dollars could be made available to the Watergate 7 if they remained quiet!
  - (5) The offer of executive clemency to the Watergate 7 was discussed by Nixon, Ehrlichman, and Colson!
  - (6) The plans for the break-in were known in advance by Haldeman, Colson, and Strachan!
  - (7) Haldeman personally selected Larry O'Brien as the target!
  - (8) Nixon ordered the Ellsberg break-in!
- 172. June 27, 1973 LaRue pleads guilty to conspiracy.
- 173. Early July 1973 A resolution for the impeachment of President Richard Nixon is introduced into the House of Representatives:
  - (1) Ulasewicz and LaRue testify before the Watergate Committee:
    - A) They have distributed \$449 thousand intended for the Watergate 7 and their lawyers.
    - B) The money is raised by Kalmbach:
      - I. Kalmbach will admit to this!!!!!
- 174. July 10, 1973 Mitchell testifies before the Watergate Committee:
  - (1) He withheld information from Nixon to safeguard the re-election campaign.
- 175. July 13, 1973 Watergate Committee staff members, Scott Armstrong & Don Sanders are questioning Alexander Butterfield:
  - (1) Ask about White House records of meetings:
    - - I. SHOCK!!!
- 176. July 16, 1973 Butterfield testifies before the Watergate Committee about the tapes.

- 177. July 17, 1973 Ervin writes to Nixon requesting the White House tapes.
- 178. July 23, 1973 Nixon refuses to give up the tapes:
  - (1) The Watergate Committee issues 2 subpoenas:
    - A) 1 for five separate taped conversations.
    - B) 1 for relevant documents.
  - (2) The Cox Committee subpoenas Nixon for 9 tapes.
- 179. July 24, 1973 Ehrlichman testifies before the Watergate Committee:
  - (1) Denies any Watergate cover-up role.....LIE!
  - (2) Says national security was the reason for the Ellsberg breakin....LIE!
  - (3) Says Nixon and his lawyers have the rightful power in the name of "National Security" to commit acts otherwise illegal!!!!!
- 180. July 25, 1973 Nixon rejects the subpoenas from both, his own special prosecutor and the United States Senate!!!!!
  - (1) Says he will give up no private Presidential papers.
- 181. July 26, 1973 The Watergate Committee votes publicly on national television <u>and</u> unanimously to pursue the President by law and bring him to court:
  - (1) Same day Archibald Cox pleads before Judge John Sirica to make the President show "just cause" why he has rejected the subpoena.
- 182. Early August 1973 Cox and Presidential counsel Wright plead their cases before Judge Sirica:
  - (1) Wright says the President is sovereign and privacy is necessary to the leadership of the United states:
    - A) To expose conversations is against executive privilege.
  - (2) Cox says the tapes are evidence in a criminal case!
- 183. August 6, 1973 The government announces that <u>Vice President</u>
  <u>Spiro Agnew</u> is under investigation by a Federal Grand Jury in Baltimore. Maryland.

- 184. August 8, 1973 Agnew is <u>charged with income tax evasion and</u>
  <u>being involved in a kick-back scheme while he was the Governor of</u>
  Maryland:
  - (1) Agnew calls the kick-back charges "Damned lies!"
  - (2) Says he will not resign.
- 185. August 15, 1973 Nixon addresses the nation on national television:
  - (1) Defends his refusal to give up the tapes!
  - (2) Urges Congress to get back to more urgent business!
- 186. August 16, 1973 Magruder pleads guilty to conspiracy charges.
- 187. August 29, 1973 Sirica rules the tapes will be turned over to him:
  - (1) He will listen to them and decide if they will be heard by a grand jury or not.
- 188. August 30, 1973 Nixon announces he will appeal Sirica's decision.
- 189. September 4, 1973 Ehrlichman, Liddy, Krogh, and Young are indicted by a Los Angeles Grand Jury for the Ellsberg break-in.
- 190. September 10, 1973 Wright argues Sirica's decision before a U.S. Court of Appeals in Washington, D.C.:
  - (1) Claims executive privilege.
- 191. October 10, 1973 Spiro Agnew resigns as Vice President of the United States:
  - (1) Has been charged with the kick-back scheme in Maryland.
  - (2) On this same day he pleads "no contest" to the income tax evasion charge:
    - A) Fined \$10 thousand and put on 3 years probation.
  - (3) Later Maryland Trial Guilty:
    - A) Was given as much as a \$1 thousand per week.
    - B) Was given a lump sum payment of \$50 thousand by contractors, architects, and engineers.
    - C) Total he raked in was over \$100 thousand in bribe money.
    - D) 1982 Repays Maryland \$248,735.00....but.....tries to deduct it from his California taxes.....doesn't work!
      - I. What about the "Damned Lies!" ?????!!??

- (4) 1996 At age 77 he dies in Maryland.
- 192. October 12, 1973 U.S. Court of Appeals votes 5-2 to uphold Sirica's decision:
  - (1) Same day Nixon nominates Gerald Ford for Vice President.
- 193. October 19, 1973 Dean pleads guilty to a charge of obstruction of justice in the cover-up:
  - (1) Same day Nixon says he will not appeal to the Supreme Court over the tapes issue.
- 194. October 20, 1973 Nixon is furious with Cox over the tapes subpoena:
  - (1) Calls Richardson Tells him to fire Cox:
    - A) Richardson says "No" Resigns.
  - (2) Haig calls Ruckelshaus Tells him to fire Cox:
    - A) Ruckelshaus says "No" Resigns.
  - (3) Haig calls Solicitor General, Robert Bork Tells him to fire Cox: A) "OK".
    - B) Drives to the White House.
    - C) Sworn in as Acting Attorney general.
    - D) Fires Archibald Cox.
    - E) Abolishes the Special Prosecutor's Office.
    - F) FBI seals off the office along with the ttorney general's Office.
      - \*\*\*\*\*Bottom line is.....Nixon has Cox fired because he is honest and won't give up his legal right to the tapes!!
- 195. October 22, 1973 The House Judiciary Committee sets up a panel of 38 men and women to look into the possibility of impeachment:
  - (1) Committee Chairman is Democratic Representative from New Jersey, Peter Rodino Jr.!
- 196. October 23, 1973 Nixon agrees to give the tapes to Sirica.
- 197. Nixon arranges for a 2<sup>nd</sup> Special Watergate Prosecutor:
  - (1) November 1, 1973 Robert Bork appoints Leon Jaworski to the position He is President of the American Bar Association.

- 198. November 5, 1973 Segretti is sentenced to 6 months in prison for 3 misdemeanor and 1 felony charge of conspiracy:
  - (1) Will serve 5 months and then is released.
- 199. Mid-November 1973 Disneyworld Florida Nixon gives a speech:
  - (1) "I'm not a crook." .....LIE!!! He is!!!!!!
  - (2) Same time IRS secretly advises the White House that there will be a thorough audit of the President's federal income tax returns from 1969 to 1972.
- 200. November 20, 1973 Krogh pleads guilty to conspiracy in the Ellsberg break-in:
  - (1) Will serve a 6 month sentence.
- 201. November 26, 1973 7 tapes are turned over to Sirica:
  - (1) Same day Nixon's Secretary, Rose Mary Woods, says she "may have mistakenly erased a portion of one of the tapes":
    - A) 18 ½ minutes of a crucial June 20, 1972 conversation between Nixon and Haldeman!!
- 202. November 27, 1973 Senate confirms Gerald Ford as Vice President.
- 203. November 29, 1973 Chapin is indicted.
- 204. Early December 1973 Ford is confirmed as Vice President by the House.
- 205. December 6, 1973 Ford is sworn in as Vice President.
- 206. December 8, 1973 Nixon releases his personal financial records for 1969 to 1973:
  - (1) Show he has paid \$78,651.00 in taxes for that period.....not enough!!!!!
- 207. January 7, 1974 Sturgis, Gonzalez, and Martinez are paroled.
- 208. January 15, 1974 Tape experts tell Sirica that most of the 18 ½ minute gap in the Nixon tape has been manually erased!

- 209. February 6, 1974 House votes 410-4 to authorize the impeachment investigation and empowers the committee to issue subpoenas.
- 210. February 25, 1974 Kalmbach pleads guilty to violating the Federal Corrupt Practices Act by his illegal fund raising activities:
  - (1) Watergate charges are dropped.
  - (2) Sentenced to 6 to 18 months in prison.
- 211. March 1, 1974 The Federal Grand Jury issues indictments in the Watergate Cover-up:
  - (1) Name: Haldeman Ehrlichman Mitchell Colson Mardian Parkinson and Strachan:
    - A) Colson resigns.
  - (2) Same day A sealed report from the Grand Jury on Nixon's alleged role in the cover-up is delivered to Judge Sirica.
- 212. March 7, 1974 Indictments are handed down in the Ellsberg break-in:
  - (1) Name: Ehrlichman Colson and Liddy.
- 213. March 18, 1974 Sirica orders the secret report on Nixon's alleged role in the cover-up delivered to the House Judiciary Committee.
- 214. March 19, 1974 Conservative Senator, James Buckley of New York makes a public statement:
  - (1) Nixon should resign.
- 215. April 3, 1974 Disclosed that Nixon owes over \$430 thousand in back taxes:
  - (1) Nixon says he will pay it plus the interest that he owes.
- 216. April 5, 1974 Chapin is convicted of perjury for lying to the Watergate Grand Jury about his connections with Segretti:
  - (1) Sentenced to 10 to 30 months in prison.
- 217. April 11, 1974 The House Judiciary Committee subpoenas Nixon for tapes and documents relating to 42 different conversations relating to Watergate.

- 218. Mid-April 1974 Disclosed to the public the names of the companies, corporations, and individuals who have made illegal contributions and how much to Nixon's 1972 campaign....will be fined....,they are:
  - (1) The merican Ship Building Company \$142 thousand.
  - (2) Carnation Corporation \$8,900 dollars.
  - (3) Diamond International Corporation \$5 thousand.
  - (4) Greyhound Corporation \$16 thousand.
  - (5) Gulf Oil Corporation \$100 thousand.
  - (6) American Airlines \$55 thousand.
  - (7) Ashland Oil Incorporated \$100 thousand.
  - (8) Braniff Airways \$40 thousand.
  - (9) Goodyear Tire and Rubber Corporation \$40 thousand.
  - (10) Minnesota Mining and Manufacturing Corporation \$30 thousand.
  - (11) Northrop Corporation \$150 thousand.
  - (12) Phillips Petroleum Corporation \$100 thousand.
  - (13) Lyles, Bissett, Carlisle, and Wolff \$10 thousand.
- 219. April 18, 1974 Sirica signs a subpoena ordering Nixon to turn over tapes of 64 conversations.
- 220. May 9, 1974 The House Judiciary Committee begins closed-door hearings in the impeachment question.
- 221. May 24, 1974 Jaworski petitions the Supreme Court to decide whether executive privilege can be used in barring access to evidence or possible evidence of misconduct:
  - (1) Same day "White House Plumbers Case":
    - A) Judge Gerhard Gesell rules that a President cannot authorize a break in without a warrant even in the name of National Security.
- 222. May 30, 1974 The House Judiciary Committee votes another subpoena warning Nixon that if he doesn't comply that it will become an impeachable offense!
- 223. May 31, 1974 The tape experts file a final report on the 18 ½ minute gap in the Nixon tape and give it to Sirica.

- 224. June 3, 1974 Ellsberg Break-in Case:
  - (1) Colson pleads guilty to obstruction of justice for devising a scheme to get and spread derogatory information about Ellsberg and interfere with his right to a fair trial:
    - A) The White House Plumber and Watergate charges are dropped.
    - B) Sentenced to 1 to 3 years in prison.
- 225. June 4, 1974 The tape experts findings are read:
  - (1) The 18 ½ minute gap has been caused by 5 to 9 manual erasures using hand controls.
  - (2) In other words.....NO ACCIDENT!!!!!
- 226. July 12, 1974 Ellsberg Break-In Case:
  - (1) Ehrlichman, Liddy, Barker, and Martinez are convicted:
    - A) Liddy 1 to 3 years for conspiracy to violate Ellsberg's civil rights.
    - B) Barker and Martinez The same except their sentences are suspended.
    - C) Ehrlichman The same <u>plus</u> perjury in lying about the White House Plumbers activities 20 months to 2 years.
- 227. July 13, 1974 The Ervin Committee releases it's final report:
  - (1) Over 7 million words!!!
- 228. July 24, 1974 The House Judiciary Committee opens it's impeachment debate:
  - (1) Same day Jaworski pleads his case before the U.S. Supreme Court:
    - A) The U.S. vs Richard Nixon.
    - B) Nixon's lawyer pleads his case.....Richard Nixon vs. The United States.
    - C) Nixon vs. The U.S. is dismissed!
    - D) Decision is 8-0:
      - I. Supreme Court has the right to decide what law is and that Nixon must turn over the tapes!!
- 229. July 27, 1974 House Judiciary Committee votes on Article 1 of the impeachment charges Obstruction of justice Passes 27-11!!

- 230. July 29, 1974 House Judiciary Committee:
  - A) Votes on Article #2 of the Impeachment charges:
    - I. Abuse of Power!
      - (1) Passes...28 to 10.
- 231. July 30, 1974 House Judiciary Committee:
  - A) Votes on Article #3 of the Impeachment charges:
    - I. Defiance of Committee Subpoenas! (1) Passes...21 to 17.
- 232. President, Richard M. Nixon has been summoned to court!!!
  - A) His involvement, his constant lying to himself, his staff, Congress, and the American people for 2 years:
    - I. Has finally caught up with him!!

#### W'gate - August 1974

- 1. August 1, 1974 Alexander Haig informs Nixon Speechwriter, Ray Price:
  - A) Start drafting a statement of resignation!
- 2. Thursday August 1, 1974 Nixon orders
  Alexander Haig to talk to Vice President, Gerald
  Ford:
  - A) Does so Topic...Options on what to do with Nixon after resignation!!
    - I. Options have been put together by J. Fred Buzhardt.
- 3. Friday August 2, 1974 John Dean is sentenced:
  - A) 1 to 4 years:
    - I. Conspiring to obstruct justice in the W'gate Cover-Up.
    - II. Defrauding the United States in the W'gate Cover-Up.
- 4. Monday August 5, 1974 Nixon issues a statement:
  - A) Admits that 6 days after the break-in:
    - I. He tried to limit the F.B.I. investigation for

#### "political reasons."

- 5. Wednesday August 7, 1974 5:00 Afternoon Nixon meets with Republican Congressional Leaders:
  - A) Barry Goldwater Hugh Scott and John Rhodes.
  - B) They advise him to resign.
  - C) That night....:
    - I. Nixon tells his family he will resign!
- 6. Thursday Night August 8, 1974 Nixon goes on national television:

        - b. Rice...Winnebego Indian...WW II...Korean War...Has been refused burial in an all-white cemetery in Nebraska.
    - II. Robert Burnette Appeals to the Federal Court:

### December 1972 William Bonin "The Freeway Murders"

### Wounded Knee II February to March 1973

- 64. January 21, 1973 Buffalo Gap, South Dakota Wesley Bad Heart Bull Found in the street Dead Knife in his chest:
  - (1) Has had a bar fight with 3 white men.
  - (2) 30 year old, service station attendant Darold Schmitz is arrested.
  - (3) Charged with 2<sup>nd</sup> degree manslaughter.
  - (4) Tribal President, Richard Wilson does not respond.
  - (5) AIM declares February 6th a day of mourning.
  - (6) Message is sent out for the Indians to gather in the town of Custer.
- 65. February 6, 1973 Custer, South Dakota Indians under Dennis Banks and Russell Means start arriving:
  - (1) Protest the murder.
  - (2) Courthouse:
    - A) State Attorney, Hobart Gates tells Means, Banks, and Dave Hill that Schmitz will be prosecuted on 2<sup>nd</sup> degree manslaughter charges!
    - B) State refuses to hear an Indian eye witness who would testify that it was cold blooded murder!
    - C) Means: "I want to know why this white man who killed an Indian was charged with 2<sup>nd</sup> degree manslaughter instead of 1<sup>st</sup> degree murder, and the only way you're going to get me out of here is to kill me."
  - (3) All hell breaks loose Fighting Fists Clubs Nightsticks Tear Gas:
    - A) Banks goes out a window and escapes.
    - B) Means and Hill knock 11 policemen down before they are subdued.
  - (4) Indians start using molotov cocktails:
    - A) Damage 2 police cars.
    - B) Burn the Chamber of Commerce and 2 other buildings.
  - (5) 27 Indians are arrested.
  - (6) 11 policemen injured.
  - (7) Means and Hill are jailed.
  - (8) National Guard is mobilized and sets up around the town.
  - (9) Sioux Lawyer, Ramon Robideaux arranges bail.
  - (10) AIM members gather in Rapid City:
    - A) Fighting breaks out.
    - B) 40 Indians are arrested.

- 66. Richard Wilson: Has illegally used tribal funds Has misused tribal funds Manages the tribe without a budget Violates the tribal constitution by refusing to call meetings in accordance with tribal law and has a "goon enforcement squad."
- 67. February 21, 1973 Pine Ridge Reservation Tribal council:
  - (1) To consider the impeachment of Richard Wilson.
  - (2) Russell Means announces that he is going to run against Wilson for Tribal Chairman.
- 68. Meeting between Wilson and Means ends when 5 of Wilson's "goon squad" arrive:
  - (1) Corner him in a parking lot.
  - (2) Try to beat him up.
  - (3) He escapes.
- 69. Pine Ridge is one big pit od squalor, poverty, oppression, and corruption:
  - (1) Very few jobs.
  - (2) Over ½ of the people are out of work.
  - (3) Housing is substandard.
  - (4) Sanitation facilities are pathetic!
  - (5) Only 9% of the homes have electricity...the other 91% do not!!!
  - (6) Only 1 out of 20 homes has running water.
  - (7) Life expectancy is very short!
  - \*\*\*\*\*The Indians are tired of it.....are going to make the U.S. and the world aware of the situation!!!
- 70. Wounded Knee, South Dakota:
  - (1) 7 Houses 2 Churches Trading Post and Museum.
- 71. Tuesday February 27, 1973 Cold evening 200 AIM members and Ogalalla Sioux take over the town:
  - (1) Start digging bunkers, shelters, and trenches around the Sacred Heart Church.
  - (2) Russell Means fully expects to die here: "I hope by my death and the deaths of all these Indian men and women, there will be an investigation into corruption on the reservations, and there's no better place to start than Pine Ridge."

- 72. U.S. Government starts sending in FBI Agents and U.S. Marshals.
- 73. Richard Wilson goes "nuts":
  - (1) Starts hiring relatives and friends as police!
  - (2) Swears to raise a force of 800 and "wipe out the AIM clowns" holding Wounded Knee!
  - (3) Asks permission from Washington to kill everyone in Wounded Knee!
- 74. Means is asked to comment on Wilson: "I cannot comment on the ravings of a drunken paranoid."
- 75. Armored personnel carriers with .50 caliber machine guns arrive.
- 76. Indians and non-Indians begin sneaking thru Federal lines bringing food and more weapons to the defenders of Wounded Knee.
- 77. Defenders set up a council to run the garrison:
  - (1) Russell Means Dennis Banks Clyde Bellecourt Carter Camp Pedro Bissonette and Leonard Crow Dog.
- 78. Carter Camp states the defenders position and demands:
  - (1) The 11 hostages will not be harmed!
  - (2) The defenders will fight to the death if they have to!
  - (3) Want Richard Wilson removed.
  - (4) Want Senator Edward Kennedy to lead an investigation into the BIA and the Department of the Interior in regards to their handling of reservations.
  - (5) Want Senator William Fullbright to investigate the 371 broken treaties.
  - (6) Want the Ogalalla Sioux to have the right to elect their own tribal officials in free elections.
- 79. The Government now has 250 FBI Agents, U.S. Marshals, and BIA Police around Wounded Knee.
- 80. Cease fire Meeting between AIM and FBI Agent in charge, Joe Trimback:
  - (1) No agreement reached.

- (2) FBI learns 3 of the hostages are trading post owner Clive Gildersleeve and his wife Agnes and the 3<sup>rd</sup> is Father Paul Manhart, Jesuit Priest of the Sacred Heart Church.
- 81. The 2 Democratic Senators from South Dakota arrive by helicopter George McGovern and James Abourezk:
  - (1) Want to get the hostages released.
  - (2) Means: "We asked to see Senator Abourezk. We didn't ask to see Senator McGovern. Senator McGovern typifies 3 individuals of the last century, General's Crook Sheridan and Custer."
  - (3) But McGovern stays for the all night talks.
  - (4) Next day Hostages are released:
    - A) 10 of the 11 opt to stay in Wounded Knee with the defenders.
- 82. Aaron DeSersa is the editor of "The Shannon County News":
  - (1) His paper supports AIM and attacks Richard Wilson.
  - (2) He supports the defenders of Wounded Knee.
  - (3) He has led reporters thru the back country into Wounded Knee,
- 83. Friday March 2, 1973 AIM leaders at Wounded Knee learn DeSersa's house has been fire-bombed and his wife badly burnt:
  - (1) His paper has been destroyed!
  - (2) AIM blames Wilson and his "goon squad."
- 84. The Justice Department attempts to undermine the morale of the defenders by announcing the Indians can depart without their weapons and face no threat of immediate arrest:
  - (1) A Grand Jury will determine charges at a later date.
  - (2) Weapons will be stacked and tagged to be returned to rightful owners at a later date.
  - (3) Indians reply that to do so is the same as signing a confession!
  - (4) Reply from defenders:
    - A) As the Indians cheer, Sacred Heart Church and the offer are burnt!
- 85. The defenders dig 2 circles of trenches around the church:
  - (1) Bunkers protected by sandbags!
  - (2) Make "molotov cocktails" from soda bottles.
  - (3) Meals are served in the church Church is also a dormitory.

- 86. Wednesday March 7, 1973 Before sunrise Light, single engine, Cessna plane Lands in Wounded Knee:
  - (1) Dr. Cummings and Pilot, Paul Davids.
  - (2) Unload 300 pounds of:
    - A) Pinto beans Brown beans Flour Sugar Condensed milk Cooking oil Canned fruit and Toilet paper.
  - (3) Most has been purchased by Michigan Indians.
  - (4) Plane takes off before daylight:
    - A) Next day Cummings and Davids will be arrested at their homes:
      - I. Charged with obstructing and impeding Federal officers under the Civil Disobedience Act of 1968.
      - II. Charged with transporting guns.
      - III. FBI will later admit they knew the "gun transportation" charge was totally false!
  - (5) Back to Wednesday night Government issues an ultimatum:
    - A) Indians must be out of Wounded Knee by the night of the 8<sup>th</sup> or action will be taken:
      - I. 6 Armored Personnel Carriers with .50 caliber machine guns move into position.
    - B) Indians reinforce the barricades:
      - I. Sing war songs.
      - II. Chant prayers.
      - III. Many of the defenders are Vietnam vets!.....Attacked by the country they have fought for!
  - (6) Across the U.S. Large numbers of Indians are prepared to rise against the U.S. if Wounded Knee is attacked:
    - A) Massive T.V. Radio and Newspaper coverage.
    - B) Flood of telegrams to White House in the greatest support of the American Indian in history!!!!!
- 87. Thursday March 8, 1973 Just before the deadline Government backs down:
  - (1) "Relief Column" outside runs the roadblocks to get into Wounded Knee:
    - A) Firing!
    - B) Shells hit Wounded Knee.
    - C) 2 Indians are wounded.
  - (2) More talks Flares all night:

- A) Flares start a prairie fire that burns 1 home.
- B) Gunbattle all night 1,000's of rounds fired.
- 88. Saturday March 10, 1973 Justice Department announces it is lifting the siege of Wounded Knee:
  - (1) Indians celebrate with a war dance and barbecue.
  - (2) Government promises to investigate the BIA, the Tribal Government at Pine Ridge, and other AIM grievances.
- 89. Sunday March 11, 1973 Evening Truce is broken:
  - (1) FBI Agent, Curtis Fitzgerald is wounded:
    - A) Flown out by helicopter with huge bandage around head and face.
    - B) ACTUALLY, wounded in the wrist!!!!!!
  - (2) 400 supporters rally at Wounded Knee.
  - (3) 6 of the 8 Tribal District Chairmen with draw their support of the Tribal Council and join AIM:
    - A) AIM now has 3 times more support than Richard Wilson.
  - (4) Wilson continues to agitate for violence:
    - A) Ask the BIA Police to remove all non-tribesman from the reservation.
    - B) He calls the National Council of Churches: "Dope pushers!"
    - C) He holds AIM responsible for all of the acts of violence!
- 90. Thursday March 15, 1973 Bad blizzard Cuts Wounded Knee off from the rest of the world:
  - (1) Is announced that 31 people have been indicted in the takeover of Wounded Knee:
    - A) Charges include burglary, larceny, conspiracy, and civil disorder.
  - (2) People at Wounded Knee are suffering Low on food, fuel, and insulin for the diabetics!
  - (3) The Justice Department announces that the National Council of Churches will be allowed to take food, fuel, and medicine into Wounded Knee.
  - (4) Richard Wilson gives his "goon squad" orders:
    - A) Sweep the reservation.
    - B) Pick up or "chase out" all undesirables!
    - C) Special "attention" is to be given to National Council of

#### Church members.

- 91. Saturday March 17, 1973 Government representative meets with Banks and Robideaux:
  - (1) Offer is.....total surrender and capitulation!
  - (2) Rejected:
    - A) Means: "In essence what they offered us was to fly us to jail!"
  - (3) Night Firefight:
    - A) 26 year old, Medic, Rocky Madrid is wounded in the stomach.
    - B) Crow Dog takes out the bullet.
- 92. Monday March 19, 1973 Committee of Pine Ridge residents present a petition with 1,400 signatures to the BIA:
  - (1) Want to establish a new Tribal Government.
  - (2) BIA claims that many of the signatures are not legal voters:
    - A) ARE all legit!
    - B) BIA later admits their lie!!!!!!
  - (3) Ramon Robideaux announces that lawyers, William Kunstler and Mark Lane are going to start a legal assault on the Justice Department concerning Wounded Knee.
- 93. Monday March 26, 1973 56 year old U.S. Marshal, Lloyd Grimm is shot in the chest at a roadblock near Wounded Knee in the heaviest firefight of the siege:
  - (1) Causes spinal damage Paralyses him Later, found to be hit by "friendly fire."
  - (2) Senator, James Abourezk makes a statement: "AIM guards are holding 100 Ogalallas who want to leave Wounded Knee."
    - A) Robideaux denies it!
- 94. April 6, 1973 Peace pact is signed Signed by Means, Camp, Bissonette, Crow Dog, and others Banks refuses to sign:
  - (1) Means will submit to arrest and go to Washington to meet with White House representatives:
    - A) As soon as Means calls and says talks have commenced disarmament will start!
  - (2) Will be a 30 to 60 day delay in the arrest of those indicted by the Federal Grand Jury.
  - (3) Will be a Federal investigation of Indian affairs at Pine Ridge.

- (4) Will be an audit of the Pine Ridge books.
- (5) Legal rights of individual Indians will be guaranteed in bringing civil suits against unlawful acts of the Tribal Council or Federal Government.
- (6) A Presidential Treaty Commission will re-examine the Treaty of 1868.
- (7) May A meeting will be held in Washington between Indian leaders and the government to discuss Indian affairs.

#### 95. Means goes to Washington:

- (1) Few days later Peace collapses.
- (2) White House wants guns turned in before talks with Means start.
- (3) The Nixon Administration has not kept it's word!!
- (4) Means refuses to order the Indians to give up their guns: "Tell them that the Indian's last treaty with the Government lasted all of 72 hours! The Government broke it before the ink was dry!"
- 96. Means starts traveling around the country to gather funds and support for Wounded Knee:
  - (1) Conditions of his \$25 thousand bail is that he not re-enter Wounded Knee.
  - (2) Senator George McGovern asks the government to clear the people out of Wounded Knee.
  - (3) The roadblocks are moved in, thus tightening the circle around Wounded Knee.
- 97. April 18, 1973 3, Single engine, Cherokee, Planes Drop food supplies into Wounded Knee:
  - (1) Firing errupts.
  - (2) Government helicopter flies over Fires thru the roof of the Church:
    - A) 6 people are wounded and <u>Frank Clearwater</u> has the back of his head blown almost totally off:
  - (3) Cease fire is called:
    - A) Clearwater is rushed to the Rapid City hospital.
    - B) Dies a week later!

# February 4, 1974 The Patty Hearst Kidnapping

- 1. February 4, 1974...University of California...

  Berkeley, California...Apartment...Off campus:
  - A) 19 year old sophomore, Patty Hearst, and her 26 year old fiancée, Steven Weed.
  - B) Shortly after 9:00 Evening:
    - I. Knock at the door.
    - II. Young white woman claims to have had an automobile accident.
    - III. Asks to use the phone.
    - IV. Convinces Weed to open the door.
    - V. She and 2 black men barge in...Knock Weed down...Kick him in the face...Knock him out with a wine bottle...Tie him up!
    - VI. Patty starts screaming: "Please, not me. Please."
    - VII. Dressed only in a blue bathrobe...She is dragged screaming from the apartment.
    - VIII. Stuffed in the trunk of a car.
    - IX. Drives off...Transferred to a station wagon driven by 2 different people.
- 2. Few days later Radio station KPFA receives a message and a Mobil Oil credit card in the name of 58 year old, Randolph Hearst:
  - A) Sent to prove his daughter has been kidnapped!

- B) Message:
  - I. Patty is the daughter of a corporate enemy of the people.
  - II. She has been served an "arrest warrant."
  - III. She will be executed if anyone tries to rescue her.

    - (1) DeFreeze...Multiple gunshot wounds ...Fatal is a .38 to the head...Suicide!
