**1. The “Mayaguez”:**

I. Extensive cheating going on in many classes.

- 4. Facts:  
A) 300 to 400 are involved!!**
  
- 5. Results:  
A) 48 of original 50 are expelled.  
B) 49 others are acquitted.  
C) 2 others resign before charges are brought.**
  
- 6. Those expelled are allowed to reapply 1 year later.**

**B) 18 year old, Donna Lauria, and 19 year old, Jody Valenti, get out of their car:**

**I. Man walks up.**

**II. Pulls out a .44 caliber revolver.**

**III. Opens fire.**

**IV. Kills Lauria and wounds Valenti.**

#### **2. THIS will start a pattern of murder targets:**

**A) Young women.**

**B) Long hair.**

**C) Alone, in cars, or in parked cars with dates.**

**D) .44 caliber revolver used!**

#### **3. October 23, 1976 – Queens, New York:**

### **The Korean Incident**

- 1. Korea – Along the 38<sup>th</sup> Parallel:**
  - A) 40,000 American troops:**
    - I. Help defend the demilitarized zone.**
    - II. With our South Korean allies.**
  - B) Short distance away...North Koreans.**
  - C) Constantly watch each other.**
  - D) Trees growing in the neutral area obscure the view.**
  
- 2. Captain Arthur Bonifas and Lt. Mark Barrett:**
  - A) Command a work detail of 9 South Koreans:**
    - I. Purpose...Prune the trees.**
  - B) 8 North Koreans arrive:**
    - I. Officer asks what is going on.**

## **1976/1977 – Winter**

### **1. Shortage of Natural Gas:**

**A) Forces many schools and businesses to close for the hard winter.**

**1. Elvis Presley – “The King” – Dies.**

**2. “Apple” – Offers the 1<sup>st</sup> Microcomputer for sale.**

**January 17, 1977**

**Gary Gilmore**

1. **Gary Gilmore – Spends most of his life in prison – Released – Goes to Provo, Utah:**
  - A) **Narcotics and booze!!!**
  - B) **Wants money to buy a pick-up.**
  
2. **July 19, 1976 – Provo, Utah – Pulls into a Sinclair Service Station:**
  - A) **The part-time attendant is Max Jensen – Young, married, Law student.**
  - B) **Gilmore forces him into the men’s restroom.**
  - C) **Forces him to lie face down on the floor.**
  - D) **Shoots him twice in the head with a .22 revolver killing him!**
  - E) **Takes money – Leaves.**
  
3. **July 20, 1976 – Provo, Utah – Walks into the Center City Motel:**
